

## **2026 LULULEMON SEAWHEEZE HALF MARATHON GROUP NON-GUARANTEED ENTRY DRAWING**

The group non-guaranteed entry drawing for the 2026 lululemon SeaWheeze Half Marathon (the "Group Drawing") presented by lululemon athletica canada inc. ("lululemon") will take place on or about February 9, 2026 ("Group Draw Date"). The entry period will begin on January 26, 2026 at 10:00 a.m. Pacific Time (PT) and will close on February 6, 2026 at 11:59 p.m. PT (the "Group Entry Period").

### **Eligibility**
