1. 我们收集的个人信息种类

The Categories of Personal Information We Collect

我们收集的信息包括您在线上或线下直接向我们提供的信息、您通过第三方人力资源服务平台 (例如前程无忧)向我们提供的信息、以及我们在与您互动过程中所形成的您的个人信息。我们 收集和形成的个人信息种类包括但不限于:

2. 我们处理个人信息的法律基础和用途

The Legal Bases on Which and Purposes for Which We Process Personal Information

Who We Share Your Personal Information With

5. 转移您的个人信息

Transfer of Your Personal Information

如lululemon发生公司重组等情形,可能会涉及向权利义务接收方转移您的个人信息。在转移您 的个人信息之前,我们将向您发送适当的通知,告知您接收方的名称或者姓名和联系方式,并确 保您的个人信息将以符合我们隐私声明的方式得到保护。接收方变更处理目的、处理方式的,我 们将会要求相关数据接收方再次获得您的同意。 In the event of a corporate restructuring or other circumstances of lululemon, we may transfer the Applicant's personal information to the transferee of our rights and obligations. If the recipient changes the purpose or manner for or in which your personal information is processed, we will require such data recipient to obtain your consent to such processing again.

8. 保留期限 Retention Period

9. 个人信息权利的行使

Exercise of Rights to Personal Information

The right to Access, Correction, Copy and Deletion

10. 敏感个人信息

Sensitive Personal Information
